
What is Staking?



Staking in Solana involves locking up SOL tokens to help secure the network and validate transactions.

Participants earn rewards in SOL based on their staked amount and the performance of the validator they support.

What is Validator?



A Solana validator is a node that validates transactions and produces new blocks by staking SOL tokens as collateral.

Validators earn rewards based on the amount of SOL they stake and the tokens delegated to them by others.


What we do

Sol Strategies runs three validators on the Solana blockchain.

This allows us to help secure the blockchain, decentralize Solana further, and collect network rewards emitted by the chain and users as payment for our services.

Sol Strategies Validator & Revenue Growth

Staking Revenue:

\$3.9M annualized as of Jan 24, 2025, up 1,252% from \$287K in fiscal 2024.

Validator Revenue:

\$9.9M annualized as of Jan 24, 2025, up 111,189% from \$8.9K in fiscal 2024.

Based on the total SOL staking rewards during the period from January 1, 2025 to January 24, 2025 (the "Period"), multiplied by the average SOL price during the Period, which is then multiplied by the average USD/CAD exchange rate.

(2) Based on the total SOL staking rewards during the period divided by the average amount of SOL staked during the Period.

(3) Based on the daily validator revenue earned during the period, multiplied by the daily SOL price and then the daily USD/CAD exchange rate



Strategic Accomplishments and Path to Nasdaq

Key Pillars of Growth

- \$55M in Strategic Financing: Strengthened liquidity to accumulate more SOL and stake to our validators at ~10% APY yield.
- Strong liquidity position of \$72M in liquid assets (crypto and cash), with a \$25M credit facility.
- OTCQX Upgrade (Sept 2024): Transitioned from Pink Sheets to OTCQX, improving investor access and credibility. Achieved a 1.75M daily average share trading volume (52-week), demonstrating strong market confidence and liquidity.
- Profitable Validator Business (Q4 Launch): Successfully launched a scalable validator operation, now generating \$13.8M in annualized revenue, making it a cornerstone of Sol Strategies' growth and financial sustainability.
- Strategic Acquisitions: Acquired OrangeFin and Cogent Crypto, bringing in advanced intellectual property, staking tools, and enhanced validator scalability, positioning Sol Strategies at the forefront of staking innovation.
- ISO 27001 Certification: Achieved globally recognized certification, reinforcing the company's commitment to operational security, transparent reporting, and adherence to high compliance standards.

- Robust Market Liquidity: 2.6M* average daily shares (CSE+OTC) traded reflects strong market confidence post-rebrand.




